AGREEMENT

I agree to follow the regulations listed below along with all rules outlined in the Chaska High School Parking Rules: 2010-2011

1. All student vehicles parked on campus must have an annual permit adhered in the lower left hand corner of the driver's side windshield with the vehicle licensed to the student and/or parent/s listed on the permit application form. Cars without a permit displayed may be immobilized or towed. _____(initial here)
2. Students are to park only in **their** assigned lot, using only one parking spot. I understand that my car may be towed or immobilized and I may be fined if it is parked in a location other than a STUDENT space in my assigned lot. Parking is prohibited in the staff lot and visitor parking areas at all times. If caught, fines double.
 - a. 1st offense-written warning _____(initial here)
 - b. 2nd offense and each subsequent offense-five school days parking suspension and/or immobilization of car with \$30 fine. _____(initial here)
 - c. 3rd offense-revocation of permit with pro-rated refund _____(initial here)
3. Students are not to move cars during the school day from arrival time until dismissal of school for the day, unless the student has special permission or a Permit to Leave Building Pass. _____(initial here)
4. Students are not to transport other students to or from campus during school hours. _____(initial here)
5. I understand the school district may use canine units in the parking lot as a means to deter the use and possession of illegal/dangerous substances. I understand that by parking in the lot and signing the permit application, I am giving consent for my vehicle to be searched or impounded if deemed suspicious by school officials _____(initial here)
6. Parking Permits are NON-TRANSFERABLE. Students caught illegally buying or selling parking permits will have the permit revoked and will also face disciplinary action. Permits will not be refunded when illegally bought or sold. _____(initial here)
